- (a) Call Report from MVFD presented by Chief Germer 32 calls / 29 responded, April to date there have been 24 emergencies on the River
- (b) Financial Report presented, of note the first Sales Tax Payment was received
- (c) New Brush Truck Reports Truck is in service and making calls. It has already been used on a grass fire. A partial payment has been requested by MVFD for the upfit costs.
- (d) Sales Tax Collection Support Company Update Ross Purcell is working with Richard Fletcher of HDL.
- (e) Building Financing Report A bond will be needed to cover the cost of the Ioan. Paula Rodriguez of Langford & Assoc. has sent our packet of forms to the USDA. If approved, we need to advertise for bids from architects next.
- (f) River Stand-By Report Chief Germer shared his concerns that historically the Sherriff's office might not be interested in including MVFD in the River Service Contract. The estimate for staffing needs was presented and Bill Hamilton noted that river calls covered by the River Staffing estimate would replace some of the calls currently included in the Call Incentive program, thereby reducing the overall incentive cost original estimate.
